I agree to pay \$40.00 per month in SNAP benefits from my June 2024 or (starting month) benefit issuance through my October 2024 issuance for a <u>Summer Vegetable CSA Share</u> (average of 3 to 8 lbs. of produce).
I agree to pay \$60.00 per month in SNAP benefits from my June 2024 (starting month) benefit issuance through my October 2024 issuance for a <u>Summer Vegetable CSA Share</u> (average of to 12 lbs. of produce).
I agree to pay \$80.00 per month in SNAP benefits from my June 2024 or (starting month) benefit issuance through my October 2024 issuance for a <u>Summer Vegetable CSA Share</u> (average of 6 to 15 lbs. of produce).
Red Fire Farm will contact you to determine your pickup schedule and frequency.
SUMMER VEGETABLES WEEKLY
I agree to pay \$178.00 per month in SNAP benefits from my June 2024 or (starting month) issuance through my October 2024 issuance for a weekly <u>Regular Summer</u> <u>Vegetable CSA Share</u> (average of 9-12 items of produce per week).
I agree to pay \$146.00 per month in SNAP benefits from my June 2024 or (starting month) issuance through my October 2024 issuance for a weekly <u>Small Summer Vegetable CSA Share</u> (6-8 items of produce per week).
SUMMER FRUIT & MUSHROOMS WEEKLY
I agree to pay \$52.40 per month in SNAP benefits from my June 2024 or (starting month) issuance through my October 2024 issuance for a weekly Summer Fruit Share (average ranging from 1-pint berries to 1 melon or 5 lbs. of apples per week).
I agree to pay \$26.60 per month in SNAP benefits from my June 2024 or (starting month) issuance through my October 2024 issuance for a weekly Summer Mushroom Share (1/3 lbs. of fresh mushrooms weekly).
FALL VEGETABLES, FRUIT & MUSHROOMS BI-WEEKLY November and December
I agree to pay \$117.00 per month in SNAP benefits from my November 2024 or (starting month) benefit issuance through my December 2024 issuance for a Fall Vegetable Share (average of 10-12 items of produce bi-weekly).
I agree to pay \$41.50 per month in SNAP benefits from my November 2024 or (starting month benefit issuance through my December 2024 issuance for a Fall Apple Share (NOV & DEC, only 10 lbs of apples/week).

II. I understand that:

- The amount I agreed to above will be automatically deducted from my EBT account on the date that I receive my SNAP benefits.
- I will receive farm produce monthly, twice monthly, or weekly for the 20 weeks from June through October, (official start and end date will be determined at the beginning of June,); or <u>bi-weekly in November and December</u>. Red Fire Farm will contact you to determine your pickup schedule and frequency.
- It is my responsibility to pick up my share on my scheduled pick-up date, during the scheduled pick-up time.
- If I cannot pick up my share, it is my responsibility to arrange for someone to pick it up for me.
- If I do not pick up my share during my scheduled pick-up time, the share will be donated to a local food pantry, and I will not get a refund.
- The types of produce in my share will change weekly. There is no guarantee on the exact amount of produce. Shares will vary in weight, size and type of produce.
- I cannot return my CSA share for a refund or exchange it for other produce.
- I can cancel my participation in the pilot at any time. If I no longer want to participate, I will ask *Red Fire Farm* staff or email <u>DTA.CSA@state.ma.us</u> for a cancellation form.
- I will complete and return the form to Red Fire Farm at least 10 days before I receive my next monthly SNAP benefit.
- If I do not return the completed form at least 10 days before that date, my CSA share payment may automatically be deducted from my next SNAP benefit. In that case, the cancellation will take effect the following month.
- I understand that *Red Fire Farm* and DTA will act on my request to cancel my payment as soon as possible.
- I understand that I will not receive a refund for CSA share payments that have already been deducted.
- I agree to participate in a brief survey about this SNAP CSA Pilot at the beginning and end of the CSA season.
- My copy of this agreement, and the notices I will receive each time a payment is deducted from my SNAP EBT
 account, will serve as receipt of payment.
